The Project Management Unit (PMU) has received budget from Government of Punjab towards the cost of establishing Punjab Public Health Agency (PPHA) in Punjab. It is intended that part of the proceeds of this budget will be applied to eligible payments under the contract for supply of following items (lot-wise)

2. PMU-PPHA now invites sealed bids from eligible bidders, manufacturers, and authorized dealers for the supply of above mentioned items (Lot-wise).
3. Interested eligible bidders may obtain bidding documents **immediately after publication of this advertisement** upon submission of a written application and payment of a non-refundable fee of Rs.500/-
4. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the Bidding Documents.
5. The bidders are required to submit their bids on **Single Stage-Two Envelope** procedure as defined in the Punjab Procurement Rules 2014 (Amended 2017)
6. Sealed Bids must be delivered to the office address mentioned below on or before **April 24, 2018 at 11:00AM**. The bids will be opened in the presence of bidders' representatives who choose to attend the opening on **April 24, 2018 at 11:30 AM** in the Committee Room of Project Management Unit (PMU), Punjab Public Health Agency (PPHA), 19-B, Block-G, Gulberg-III, Lahore.
7. The bids must be accompanied by a Bid Security mentioned against each lot in the form of CDR, pay order, demand draft, or banker's cheque in favor of **"Secretary Primary & Secondary Healthcare Department, Govt. of the Punjab"** from a Scheduled Bank of Pakistan.
8. The bidders are requested to give their best and final prices as no negotiations are expected. The bids will be evaluated on lot basis, however, the bidders must quote price of each item on unit basis.
9. Taxes will be deducted as per applicable government rules. NTN and Sales Tax registration certificates must be provided.
